Water is on

Water at the allotments is on for your gardening needs. As usual, follow courtesy, consideration and conservation standards when using water on your plots and please report if you experience any issues related to the water and/or taps.

Sycamore Sprouts



Look out for Sycamore seedlings! This time of year, Sycamore seedlings are a real problem as they come up everywhere. Over time, they can grow into very large trees, but luckily, they are very easy to pull out when newly germinated. If left a few months, they can be difficult to remove and extremely difficult after a year or two. Remember, it's also a part of your responsibility as a member not to allow non-fruit trees to grow on your plot.



Compliance Reminders

Please be mindful of any nuisance you might cause to neighbours with your activity on your plot (e.g. guest behaviour, loud music).

Only one car per plot allowed due to limited parking spaces. This is to ensure members are afforded spaces and access to allotments as priority.

If you are looking to make any changes to fencing, borders or hedging, please contact the committee (<u>info@whetstonestrayallotments.co.uk</u>) with your proposed updates. The committee will review and advise if you can go ahead.

Inspections

Inspections are around the corner in May! Please ensure your plots are in compliance with cultivation standards. Some guidance for ensuring you are meeting requirements and are prepared to pass inspection to follow.
